## PARTICIPATION AGREEMENT BETWEEN

The Swedish Cultural Society (Svenska Kulturföreningen i Vancouver), hereinafter known as SCS, and whose representative for the purpose of this agreement and negotiations pertaining hereto is AnnaKarin Tornqvist

**AND**

\_\_\_\_\_ hereinafter known as the Vendor, in respect to the Swedish Christmas Fair/ Svensk Julmarknad to be held on **November 18-19, 2017** between the hours of 11:00 a.m. and 4:00 p.m. both days.

SCS hereby agrees

1. to provide previously reserved and rented premises in the Scandinavian Community Centre, 6540 Thomas Street, Burnaby.
2. to provide the number of tables, chairs and other pieces of equipment as have been requested by the Vendor and agreed upon by SCS on or before September 5<sup>th</sup>, 2017.
3. to advertise to the public at large in public media as well as by posters in public areas.
4. that all proceeds from the sale by the Vendor at the aforesaid market shall be retained by the Vendor.
5. that SCS reserves the right to limit items offered for sale and to verify conformance to the Participation Agreement. Homemade jams and preserves and baked goods cannot be sold unless Vendor has valid food permit from Fraser Health Authority, Burnaby.

4. to pack up and remove from the premises, at his/her expense, any belongings left over after the sale, between the hours of 4:00 p.m. and 6:00 p.m. on November 19<sup>th</sup>, 2017.
5. to provide at his/her own expense personnel to assume responsibility for the goods, Vendor's belongings and anything brought to the premises by the Vendor.
6. that the SCS shall not be held liable to losses due to theft, breakage, fire, acts of God or any other causes for the duration of the Christmas Fair, including nights, neither during transportation to and from the Christmas Fair nor during the hours that the Christmas Fair is in preparation or open to the public.
7. I have read, understood, and agree to comply with the Participation Agreement as set out by SCS.
